1.0 PURPOSE

Queensland Academy for Science, Mathematics and Technology (QASMT) is committed to providing a safe, respectful and disciplined learning environment for students and staff, where students have opportunities to engage in quality learning experiences and acquire values supportive of their lifelong wellbeing.

This QASMT Student Code of Conduct is designed to facilitate high standards of behaviour, so that the learning and teaching in our Academy can be effective and students can participate positively within our school community.

2.0 LEARNING BEHAVIOUR STATEMENT

All areas of the Queensland Academy for Science, Mathematics and Technology are learning and teaching environments. We consider behaviour management to be an opportunity for valuable social learning as well as a means of maximising the success of academic education programs.

Our Student Code of Conduct outlines our system for facilitating positive behaviours, preventing problem behaviour and responding to unacceptable behaviours. Through our school plan, shared expectations for student behaviour are clear to everyone, assisting Queensland Academy for Science, Mathematics and Technology to create and maintain a positive and productive learning and teaching environment, where all school community members have clear and consistent expectations and understandings of their role in the educational process.

Our school community has identified the following school protocols to teach and promote our high standards of responsible behaviour. This is known as the SMT Way:

- Show respect
- Maintain safety
- Take responsibility

These protocols support our pursuit of academic excellence, our commitment to leadership development, and striving for our personal best in strategic endeavours.

We believe:

- Student behaviour is an educational issue rather than just a management issue
- Parents/Caregivers play a primary role in supporting and nurturing their student, so our work with young people flourishes when we can work together
- Students learn best when they:
 - feel safe and confident
 - are treated with understanding, respect and politeness
 - feel challenged by the tasks they are completing
 - feel pride in their achievements
 - can work in a supportive classroom environment

- are emotionally and physically well
- have a sense of belonging to the school community

Our school protocols are aligned with the values, principles and expected standards outlined in the Department of Education's Code of School Behaviour and Chapter 12 of the Education General Provisions Act 2006.

3.0 WHOLE SCHOOL APPROACH TO DISCIPLINE

Queensland Academy for Science, Mathematics and Technology developed this Student Code of Conduct in collaboration with our school community. Broad consultation with parents/caregivers, staff and students was undertaken in November 2017 and throughout 2018 and 2019, for publication of the Student Code of Conduct in 2020, with a further review and refinement in 2024. A review of school data sets relating to attendance, participation and student disciplinary absence also informed this development and refinement process.

This is a whole-school approach to discipline, used in classrooms and programs offered through the school, including all Education Outside the Classroom (EOTC) activities. The Student Code of Conduct has been informed by the AITSL Professional Standards of teaching practice, with particular consideration given to Standard 4, to create and maintain safe learning environments. The QASMT Student Code of Conduct was also developed through the lens of the QASMT Positive Psychology Framework, which centres on students flourishing through cultivating positive emotions, engagement, positive relationships, meaning and achievement.

This is an evidence-based framework used to:

- Analyse and improve student behaviour and learning outcomes
- Ensure that only evidence-based practices are used correctly by teachers to support students
- Continually support staff members to maintain consistent school and classroom improvement practices

These expectations are communicated to the whole school community, and implemented with students through the following processes and strategies to support student behaviour, including:

- House Dean active leadership
- Active supervision by staff
- Student handbook
- Enrolment procedures
- School Website
- Engagement and transition programs
- Positive Education Program (PEP), IBL and Respectful Relationship lessons
- Bespoke programs run throughout the year for different year levels, such as the Love Bites program.
- Positive Education Framework and INSTEP programs
- Assemblies (House, Year Level, Whole School)

- Parent Information presentations and newsletters

4.0 CONSIDERATION FOR INDIVIDUAL CIRCUMSTANCES

Staff at QASMT take into account students' individual circumstances, such as their behaviour history, disability, mental health and wellbeing, religious and cultural considerations, home environment and care arrangements when responding to inappropriate behaviour or applying a disciplinary consequence. To ensure alignment with the Student Code of Conduct when applying consequences, the individual circumstances and actions of the student and the needs and rights of school community members are considered.

In considering the individual circumstances of each student, we recognise that the way we teach, the support we provide and the way we respond to students will differ. This reflects the principle of equality, where every student is given the support they need to be successful. Some students may need additional support to interpret or understand an expectation. Others may benefit from more opportunities to practise a required skill or behaviour. For a small number of students, the use of certain disciplinary consequences may be considered inappropriate or ineffective due to complex trauma or family circumstances. These are all matters that our staff consider with each individual, in both the instruction of behaviour expectations and the response to student behaviour. Staff at QASMT also follow Department of Education requirements regarding confidentiality obligations- limiting discussions or sharing information about individual circumstances of students, including disciplinary consequences, with persons other than the student's parents or caregivers.

Queensland Academy for Science, Mathematics and Technology considers the individual circumstances of students when applying support and consequences by:


- promoting an environment which is responsive to the diverse needs of its students
- establishing procedures for applying fair, equitable and non-violent consequences for infringement of the code ranging from the least intrusive sanctions to the most stringent
- recognising and taking into account students' age, gender, disability, cultural background, socioeconomic situation, mental health and wellbeing and their emotional state; and
- recognising the rights of all students to:
 - express opinions in an appropriate manner and at the appropriate time
 - work and learn in a safe environment regardless of their age, gender, disability, cultural background or socio-economic situation
 - receive adjustments appropriate to their learning or impairment needs
 - provide written or verbal statements that will be taken into consideration in the decision- making processes; and
 - ensure that processes maintain the dignity, respect, privacy, and confidentiality of the student, consistent with the rights of the rest of the community.

5.0 DIFFERENTIATED AND EXPLICIT TEACHING

QASMT is a disciplined school environment that provides differentiated teaching to respond to the learning needs of all students. This involves teaching expected behaviours and providing opportunities for students to practise these behaviours. Teachers reinforce expected behaviours, provide feedback and correction, as well as opportunities for practise.

As part of a whole school approach to support student learning, QASMT staff may vary what students are taught, how they are taught and how students can demonstrate what they know as part of this differentiated approach to behaviour. These decisions about differentiation are made in response to data and day-to-day monitoring that indicates the behavioural learning needs of students. This enables our teachers to purposefully plan a variety of ways to engage students; assist them to achieve the expected learning; and to demonstrate their learning.

Individual needs and circumstances are addressed through reasonable adjustments to teaching, curriculum and assessment. This is addressed through a three-layered approach to differentiation, as illustrated in the diagram below. This model is used for both academic and pedagogical differentiation.



5.1 FOCUSED TEACHING

A small percentage of all students in any classroom may require additional support to meet behaviour expectations, even after being provided with differentiated and explicit teaching. These students may have difficulty meeting behavioural expectations in a particular period of the day or, as part of a learning area/subject, and focused teaching is provided to help them achieve success. In most cases, the problem behaviours of these students may not be immediately regarded as severe, but the frequency of their behaviours may put these students' learning and social success at risk if not addressed in a timely manner.

Focused teaching involves revisiting key behavioural concepts and/or skills and using explicit and structured teaching strategies in particular aspects of a behaviour skill. Focused teaching provides students with more opportunities to practise skills and multiple opportunities to achieve the intended learning and expected behaviour.

These students are supported through the work of the teachers, House Deans, Guidance Officers, Head of Department Inclusion and Wellbeing and Student Services support staff team. A range of strategies is employed to assist the student to redirect behaviour and to develop the skills to be successful at school.

5.2 INTENSIVE TEACHING

Queensland Academy for Science, Mathematics and Technology recognises that students with highly complex and challenging behaviours may need comprehensive systems of support that require regular reviews in consultation with parents/caregivers and other relevant specialist staff. The House Deans facilitate the assessment and support process, in conjunction with the Guidance Officers, Head of Department Inclusion and Wellbeing and/or Senior Leadership (if required).

The House Deans:

- Develop appropriate behaviour expectations and strategies with other staff members
- Monitor the impact of support for individual students through continuous data collection; and
- Consult with the Senior Leadership Team over recommended process.

In some cases the House Deans, in conjunction with the Guidance Officers, Head of Department Inclusion and Wellbeing and/or Senior Leadership:

- Provide consistent strategies and adjustments outlined within the Educational Adjustment Program; and
- Engage with external agencies, to support the student and their family.

As a fully selective entry school based on academic ability, behaviour - and a high level of commitment and application to study, our resourcing is directed towards the support of academic success.



6.0 DISCIPLINARY CONSEQUENCES

6.1 PROCESS FOR FACILITATING STANDARDS OF POSITIVE BEHAVIOUR AND RESPONDING TO UNACCEPTABLE BEHAVIOUR

The first step in facilitating standards of positive behaviour is communicating those standards to **all** students. At the Queensland Academy for Science, Mathematics and Technology, we emphasise the importance of directly teaching students the behaviours we want them to demonstrate at school- *the SMT Way*. Communicating behavioural expectations is a form of universal behaviour support - a strategy directed towards **all** students, which is designed to prevent problem behaviour and to provide a framework for responding to unacceptable behaviour.

A set of behavioural expectations in specific settings has been attached to each of our three school protocols. The School Wide Expectations Teaching Matrix below outlines our agreed protocols and specific behavioural expectations in all school settings.

6.2 CONSEQUENCES FOR UNACCEPTABLE BEHAVIOUR

Queensland Academy for Science, Mathematics and Technology makes systematic efforts to prevent problem student behaviour by teaching and reinforcing expected behaviours on an ongoing basis. When unacceptable behaviour occurs, students experience predictable consequences. Our school seeks to ensure that responses to unacceptable behaviour are consistent and proportionate to the nature of the behaviour. OneSchool is used to record all minor and major problem behaviours. A pattern of minor behaviours may constitute a major behaviour.

6.3 MINOR AND MAJOR BEHAVIOURS

When responding to problem behaviour incidents, the staff member first determines if the problem behaviour is major or minor.

Minor behaviours are those that:

- are minor breaches of the protocols
- do not seriously harm others or have the potential to cause harm
- do not violate the rights of others or have the potential to violate the rights of others
- are not part of a pattern of inappropriate behaviours
- do not usually require involvement of specialist support staff, House Deans, the Senior leadership team and/or Heads of Department.

In the case of a minor behaviour breach:

- Parent/caregiver contact and recorded on OneSchool
- If required or appropriate:
 - Referral to House Dean, Head of Department Inclusion and Wellbeing, Guidance Officer or external specialist; and/or placement on monitoring processes

Major behaviours are those that:

- may violate the rights of others or have the potential to violate the rights of others
- may put others/self at risk of harm or potential harm
- may constitute misconduct, disobedience or conduct that is prejudicial to the good order and management of the school
- may be a pattern of repeated minor behaviours.

The following table outlines **examples** of minor and major problem behaviours (**these example behaviours are not an exhaustive list**):

A minor behaviour that occurs online, and/or inside or outside of school will all be dealt with under the Student Code of Conduct. An example of a consequence for a minor behaviour breach may be (but is not limited to) one or more of the following:

- Warning, redirection or reminder of *SMT Way* protocols
- Apology
- Detention or reflection
- Restorative practice
- Loss of privilege
- Restitution
- Removal from activity (in line with the DOE Restrictive Practice Procedure) or moving away from other students
- individual meeting with the student
- temporary removal of property (in line with QASMT Temporary Removal of Property Policy and Procedure)
- Mediation
- Counselling to relate problem behaviour with expected behaviour

Major behaviours result in a referral to the House Deans and/or Senior Leadership Team because of their seriousness. A major behaviour that occurs online, and/or inside or outside of school will be dealt with under the Student Code of Conduct

When major problem behaviour occurs, staff members calmly state the major problem behaviour to the student and remind them of the expected school behaviour. In each case of a major behaviour breach, the following actions will be taken:

- Parent/ caregiver contact and recorded on OneSchool
- Referral to House Dean, Head of Department or Senior leader for investigation and decision of appropriate consequence

- If required or appropriate:
 - Referral to Head of Department Inclusion and Wellbeing, Guidance Officer or external specialist; and/or placement on monitoring or discipline
 - improvement processes

A major behaviour that occurs online, and/or inside or outside of school will all be dealt with under the Student Code of Conduct. An example of a consequence for a major behaviour breach may be (but is not limited to) one or more of the following:

- Enactment of the Enrichment and Leadership Policy protocols
- Warning, redirection or reminder of *SMT Way* protocols
- Apology
- Detention or reflection
- Restorative practice
- Loss of privilege
- Restitution
- Removal from Activity (in line with the DOE Restrictive Practice Procedure)
- Time Out
- Suspension
- Exclusion
- Behaviour, Anti-bullying, Dress Code, Attendance or Effort contract
- Discipline Improvement Plan
- Police or child services notification, where necessary
- Warning notice of cancellation or cancellation of enrolment
- Temporary removal of property (in line with QASMT Temporary Removal of Property Policy and Procedure)

6.4.1 Detention

A detention may be held during school hours, out of school hours or on non-school days for any student in Years 7-12. Decision making regarding a detention will include an assessment of the student's behaviour and the level of risk, as well as the individual circumstances of the student.

6.4.2 For Detention within School Hours

Parents/Caregivers may be notified by the Principal, or Principal's delegate, if a student is placed on detention. The normal school break time schedule will be observed for the student on detention however, the student may not be permitted to converse with other students during the detention period. The student will be given the opportunity for food, toilet and rest breaks, as per normal school routine.

6.4.3 For detentions issued for outside of school hours, including non-school days

A detention issued outside of school hours, including non-school days, will never be more than the duration of a normal school day. The student will be given the opportunity for food, toilet and rest breaks, as per normal school routine. The student's attendance at the detention will be recorded. A risk assessment will be completed and a risk management plan developed.

Parents/caregivers will be notified of the proposed detention at least 24 hours before the detention is scheduled to occur and have given consent. Parents/Caregivers will be consulted about suitable times for the detention to be completed, within the parameters set by the school.

Parents/Caregivers will be informed of:

- location and duration of the detention
- their responsibility to arrange travel/supervision to and from the detention, where appropriate
- The supervision arrangements for the student during the detention

7.0 SCHOOL DISCIPLINARY ABSENCES (SDA)

A School Disciplinary Absence (SDA) is an enforced period of absence from attending a Queensland state school, applied by the Principal, as a consequence to address poor student behaviour. There are four types of SDA:

- Short suspension (1 to 10 school days)
- Long suspension (11 to 20 school days)
- Charge-related suspension
- Exclusion (period of not more than one year or permanently).

Parents/caregivers and students may only appeal a long suspension, charge-related suspension or exclusion decision. A review will be conducted by the Director-General or their delegate, and a decision made within 40 school days to confirm, amend/vary or set aside the original SDA decision by the Principal. The appeal process is a thorough review of all documentation associated with the SDA decision and provides an opportunity for both the school and the family to present their case in the matter. Time is afforded for collection, dissemination and response to the materials by both the school and the family. It is important that the purpose of the appeal is understood so that expectations are clear, and appropriate supports are in place to ensure students can continue to access their education while completing their SDA.

7.1 RE-ENTRY FOLLOWING SUSPENSION

Students who are suspended from QASMT will be invited, with their parents/caregivers, to attend a re-entry meeting on the day of their scheduled return to school. The main purpose of this meeting is to offer support to transition the student, back to the school. It is not a time to review the student's behaviour or the decision to suspend as the student has already received a punishment through their disciplinary absence from school. The aim of the re-entry meeting is for school staff to set the student up for future success and strengthen home-school communication.

7.2 ARRANGEMENTS

The invitation to attend the re-entry meeting will be communicated to the student and parents/caregivers, usually via email. A record of the meeting will be saved in OneSchool, under the Contact or Behaviour tab, including any notes or discussions occurring during the meeting.

7.3 REASONABLE ADJUSTMENTS

In planning the re-entry meeting, school staff will consider reasonable adjustments needed to support the attendance and engagement of the student. This includes selecting an appropriate and accessible meeting space, organising translation or interpretation services or supports (e.g. AUSLAN), provision of written and/or pictorial information and other relevant accommodations. The inclusion of support staff, such as guidance officers, may also offer important advice to ensure a successful outcome to the re-entry meeting.

8.0 THE RELATIONSHIP BETWEEN PROBLEM BEHAVIOURS AND EXPECTED SCHOOL BEHAVIOURS

When responding to problem behaviours, staff members ensure that students understand the relationship of the problem behaviour to expected school behaviour. One method that staff members might use to achieve this is to have students:

- articulate the relevant expected school behaviour
- explain how their behaviour differs from expected school behaviour
- describe the likely consequences if the problem behaviour continues
- identify what they will do to change their behaviour in line with expected school behaviour

Should a problem behaviour be repeated, the staff member might not repeat the discussion/explanation process but simply remind the student of the consequences of their problem behaviour.

9.0 ENSURING CONSISTENT RESPONSE TO PROBLEM BEHAVIOURS

At the Queensland Academy for Science, Mathematics and Technology, staff members authorised to issue consequences for problem behaviour are provided with appropriate professional development and/or training. Through training activities, we work to ensure consistent responses to problem behaviour across the school.

Students also receive training in how to respond appropriately when other students display problem behaviour and the courteous way to respond when a staff member re-directs their behaviour or consequences are applied for problem behaviour.

9.2 TEMPORARY REMOVAL OF STUDENT PROPERTY

The removal of any property in a student's possession may be necessary to promote the caring, safe and supportive learning environment of the school, to maintain and foster mutual respect between all state school staff and students. The QASMT Temporary Removal of Student Property Policy outlines the processes, conditions and responsibilities for the Principal and school staff when temporarily removing student property.

In determining what constitutes a reasonable time to retain student property, the Principal, or Principal's delegate, will consider:

- the condition, nature or value of the property
- the circumstances in which the property was removed
- the safety of the student from whom the property was removed, other students or staff members
- good management, administration and control of the school.

The Principal, or Principal's delegate, will determine when the temporarily removed student property can be returned, unless the property has been handed to the Queensland Police Service.

The following items are explicitly prohibited at QASMT and will be removed if found in a student's possession:

- illegal items or weapons (e.g. guns, knives*, throwing stars, brass knuckles, chains)
- imitation guns or weapons
- potentially dangerous items (e.g. blades, rope)
- drugs or any illicit substance (including tobacco)
- alcohol
- aerosol deodorants or cans (including spray paint)
- explosives (e.g. fireworks, flares, sparklers)
- flammable solids or liquids (e.g. fire starters, mothballs, lighters)
- poisons (e.g. weed killer, insecticides)
- inappropriate or offensive material (e.g. racist literature, pornography, extremist propaganda).

* No knives of any type are allowed at school, including flick knives, ballistic knives, sheath knives, push daggers, trench knives, butterfly knives, star knives, butter knives, fruit knives or craft knives, or any item that could potentially be used as a weapon, for example a chisel. Knives needed for school activities will be provided by the school, and the use of them will be supervised by school staff. In circumstances where students are required to have their own knives or sharp tools for particular subjects or courses, the school will provide information about the procedures for carrying and storing these items at school.

9.3 RESPONSIBILITIES

The Principal, or Principal's delegate, at QASMT

- does not require the student's consent to search school property such as lockers, desks or electronic devices that are supplied to the student through the school.
- may seize, but not open, a student's bag where there is suspicion that the student has a dangerous or illegal item (for example, a knife or alcohol) in their school bag, prior to seeking consent to search from a parent/caregiver or calling the police.
- must seek consent from the student or parent/caregiver to examine or otherwise deal with the temporarily removed student property. For example, staff who temporarily remove a mobile phone from a student are not authorised to unlock the phone or to read, copy or delete messages stored on the phone.
- must seek consent from the student or parent/caregiver to search the person of a student (e.g. pockets or shoes). If consent is not provided and a search is considered necessary, the police and the student's parent/caregiver will be called to make such a determination.

There may, however, be emergency circumstances where it is necessary to search a student's property without the student's consent or the consent of the student's parents/caregivers (e.g. to access an EpiPen for an anaphylactic emergency). The administration of medications to students by school staff is only considered when a prescribing health practitioner has determined that it is necessary or when there is no other alternative in relation to the treatment of a specific health need. Schools require medical authorisation to administer any medication to students (**including over-the-counter medications such as paracetamol or alternative medicines**).

Parents/Caregivers of students at QASMT

- will ensure their student does not bring property onto schools grounds or other settings used by the school (e.g. camp, sporting venues) that:
 - is prohibited according to the QASMT Student Code of Conduct
 - is illegal
 - puts the safety or wellbeing of others at risk
 - does not preserve a caring, safe, supportive or productive learning environment
 - does not maintain and foster mutual respect;
- will collect temporarily removed student property as soon as possible, after notification by the Principal or Principal's delegate that the property is available for collection.

Students at QASMT

- will not bring property onto school grounds or other settings used by the school (e.g. camp, sporting venues) that:
 - is prohibited according to the QASMT Student Code of Conduct
 - is illegal
 - puts the safety or wellbeing of others at risk
 - does not preserve a caring, safe, supportive or productive learning environment
 - does not maintain and foster mutual respect

- will collect their property as soon as possible when advised by school staff that it is available for collection.

10.0 USE OF MOBILE PHONES AND OTHER DEVICES BY STUDENTS

Digital literacy refers to the skills needed to live, learn and work in a society where communication and access to information is dominated by digital technologies like mobile phones. However, the benefits brought about through these diverse technologies can be easily overshadowed by deliberate misuse, which harms others or disrupts learning.

In consultation with the broader school community, QASMT has determined that explicit teaching of responsible use of mobile phones and other devices is a critical component of digital literacy. The knowledge and confidence to navigate and use these technologies safely while developing digital literacy is a responsibility shared between parents/caregivers, school staff and students.

It is also agreed that time and space should be provided at school where technology is not permitted for students in Years 7-9, and those students are encouraged to engage in other social learning and development activities. Students in Years 7-9 are not permitted to use mobile phones or electronic devices during break times and before and after school. If students in Years 7-9 wish to contact parents/caregivers whilst at school, they must do so in the presence of the attendance officer, located in student services precinct. Students in Years 7-9 who are using their electronic devices for study during break times or before and after school may do so under supervision in the research centre.

Students in Years 7-12 must not use mobile phones in classroom without the explicit permission of the teaching staff.

10.1 RESPONSIBILITIES

The responsibilities for students using mobile phones or other devices at school and outside school, are outlined below; further information on the responsibilities for staff, students and parents/caregivers is also outlined in the Responsible Use of Mobile Phones and Other Devices Policy.

It is **acceptable** for students at QASMT to:

- use electronic devices safely and responsibly for
 - assigned class work and assignments set by teachers
 - developing appropriate literacy, communication and information skills
 - authoring text, artwork, audio and visual material for publication on the intranet or internet for educational purposes as supervised and approved by the school
 - conducting general research for school activities and projects
 - communicating or collaborating with other students, teachers, parents/caregivers or experts in relation to school work
 - accessing online references such as dictionaries, encyclopaedias, etc.

- researching and learning through the department's eLearning environment
- be courteous and considerate of others when using an electronic device
- respect the rights and confidentiality of others
- follow the direction of teachers when using an electronic device and seek approval where they wish to use an electronic device under special circumstances.

It is **unacceptable** for students at QASMT to:

- use a mobile phone or other devices in an unlawful manner
- film, photograph, screen capture, or record members of the Academy community without permission and they must not share or use these artefacts without permission.
- use a mobile phone in technology-free designated spaces or times (Students in Years 7-9)
- download, distribute or publish offensive messages or pictures
- use obscene, inflammatory, racist, discriminatory or derogatory language
- use language and/or threats of violence that may amount to bullying and/or harassment, or even stalking
- insult, harass or attack others or use obscene or abusive language
- deliberately waste printing and internet resources
- damage computers, printers or network equipment
- commit plagiarism or violate copyright laws
- ignore teacher directions for the use of social media, online email and internet chat
- send chain letters or spam email (junk mail)
- knowingly download viruses or any other programs capable of breaching the department's network security
- use in-phone cameras anywhere a normal camera would be considered inappropriate, such as in change rooms or toilets
- invade someone's privacy by recording personal conversations or daily activities and/or the further distribution (e.g. forwarding, texting, uploading, Bluetooth use etc.) of such material
- use a mobile phone or other electronic device (including devices with Bluetooth functionality) during exams or assessments unless expressly permitted by school staff.

At all times students, while using ICT facilities and devices supplied by the school, will be required to act in line with the requirements of the QASMT Student Code of Conduct. In addition, students and their parents/caregivers should:

- understand the responsibility and behaviour requirements (as outlined by the school) that come with accessing the department's ICT network facilities.
- ensure they have the skills to report and discontinue access to harmful information if presented via the internet or email.
- be aware that:

- access to ICT facilities and devices provides valuable learning experiences for students and supports the school's teaching and learning programs
- schools may remotely access departmentally-owned computers or mobile devices for management purposes
- students who use a school's ICT facilities and devices in a manner that is not appropriate may be subject to disciplinary action by the school, which could include restricting network access
- despite internal departmental controls to manage content on the internet, illegal, dangerous or offensive information may be accessed or accidentally displayed
- teachers will always exercise their duty of care, but avoiding or reducing access to harmful information also requires responsible use by the student.

11.0 PREVENTING AND RESPONDING TO BULLYING

QASMT uses the QASMT Positive Education Framework and the [Australian Student Wellbeing Framework](#) to promote positive relationships and the wellbeing of all students, staff and visitors at the Academy. Our staff know that student learning is optimised when they feel connected to others and experience safe and trusting relationships. Students who feel secure are more likely to be active participants in their learning and to achieve better physical, emotional, social and educational outcomes. Teachers who feel valued and supported are more likely to engage positively with students and build stronger connections within the school community. Parents/Caregivers who are positively engaged with their child's education leads to improved student self-esteem, attendance and behaviour at school. Enhancing the wellbeing of students and their educators delivers overall long-term social, health and economic benefits to the Australian community.

QASMT has an Academy Representative Council (ARC), with diverse representatives meeting regularly with the school leadership team to promote strategies to improve student wellbeing, safety and learning outcomes. A priority for the ARC is to contribute to the implementation of strategies that enhance wellbeing, promote safety and counter bullying and abuse in all online and physical spaces.

11.1 BULLYING

The agreed national definition for Australian schools describes bullying as:

- Ongoing and deliberate misuse of power in relationships through repeated verbal, physical and/or social behaviour that intends to cause physical, social and/or psychological harm.
- Involving an individual or a group misusing their power, or perceived power, over one or more persons who feel unable to stop it from happening.
- Happening in person or online, via various digital platforms and devices and it can be obvious (overt) or hidden (covert). Bullying behaviour is repeated, or has the potential to be repeated, over time (for example, through sharing of digital records).
- Having immediate, medium and long-term effects on those involved, including bystanders.


Behaviours that do not constitute bullying include:

- Single incidents and conflict or fights between equals, whether in person or online
- Mutual arguments and disagreements (where there is no power imbalance)
- Not liking someone or a single act of social rejection
- One-off acts of meanness or spite
- Isolated incidents of aggression, intimidation or violence.

However, these conflicts are still considered serious and need to be addressed and resolved. Academy staff will work to quickly respond to any matters raised of this nature in collaboration with students and parents/caregivers.

The following flowchart explains the actions QASMT teachers will take when they receive a report about student bullying, including bullying which may have occurred online or outside of the school setting. **The key contact for students and parents/caregivers to report bullying is the student’s House Dean.**

11.2 BULLYING RESPONSE FLOWCHART FOR QASMT STAFF



- Document the plan of action in OneSchool
- Complete all actions agreed with student and parent/caregiver within agreed timeframes
- Monitor student and check in regularly on their wellbeing

Day 5 Review

- Meet with the student to review situation
- Discuss what has changed, improved or worsened
- Explore other options for strengthening student wellbeing or safety

Ongoing Follow Up

- Continue to check in with student on regular basis until concerns have been mitigated
- Record notes of follow up meetings in OneSchool
- Refer matter to specialist staff within 48 hours if problems escalate
- Look for opportunities to improve school wellbeing for all students

12.0 CYBERBULLYING

Cyberbullying is treated at QASMT with the same level of seriousness as in-person bullying. The major difference with cyberbullying however, is that unlike in-person bullying, cyberbullying follows students into their community, their homes and their bedrooms, giving them no opportunity to escape the harassment or abuse during the evening, weekends or holidays.

In the first instance, students or parents/caregivers who wish to make a report about cyberbullying should approach the student's House Dean.

It is important for students, parents/caregivers and staff to know that state school Principals have the authority to take disciplinary action to address student behaviours that occur outside of school hours or school grounds. This includes cyberbullying. Parents/Caregivers and students who have concerns about cyberbullying incidents occurring during school holidays should immediately seek assistance through the [Office of the e-Safety Commissioner](#) or the Queensland Police Service.

Students enrolled at QASMT may face in-school disciplinary action, such as detention or removing of privileges, or more serious consequences such as suspension or exclusion from school, for engaging in behaviour that adversely affects, or is likely to adversely affect, other students or the good order and management of the Academy. This includes behaviour such as cyberbullying, which occurs outside of school hours or settings, for example on the weekend or during school holidays. It also applies to inappropriate online behaviour of enrolled students that is directed towards other community members or students from other school sites.

Parents/Caregivers or other stakeholders who engage in inappropriate online behaviour towards students, staff or other parents/caregivers may be referred to the Office of the e-Safety Commissioner and/or the Queensland Police Service. State school staff will be referred for investigation to the Integrity and Employee Relations team in the Department of Education.

12.1 QASMT CYBERBULLYING RESPONSE FLOWCHART FOR SCHOOL STAFF

How to manage online incidents that impact your school

Student protection

If at any point the principal forms a reasonable suspicion that a student has been harmed or is at risk of harm, they have a responsibility to respond in accordance with the [Student protection procedure](#).


Explicit images

If the investigation involves naked or explicit images of children, staff should not save, copy, forward or otherwise deal with the content, as per the [Temporary removal of student property by school staff procedure](#). This includes onto OneSchool records. Refer to the investigative process outlined in 'Responding to incidents involving naked or explicit images of children' from the [Online Incident management guidelines](#).

12.2 CYBERSAFETY AND REPUTATION MANAGEMENT (CRM)

The Department of Education employs a dedicated team of experts to assist in maintaining the integrity of the department's reputation with regard to cybersafety and reputation management issues, effectively leading the development and implementation of departmental cybersafety processes.

This team provides **direct support for schools** to respond to concerns of inappropriate online behaviour and misuse of information and communication technology.

12.3 STUDENT INTERVENTION AND SUPPORT SERVICES

QASMT recognises the need to provide intervention and support to all students involved in incidents of bullying, including cyberbullying. Students who have been subject or witness to bullying have access to a range of Academy support staff. Depending on the nature of the reported bullying incident, a formal plan of action may be developed and documented to support the implementation of strategies to assist the student.

Students who engage in bullying behaviours towards others will also be provided with support to assist them to use more socially acceptable and appropriate behaviours in their interactions. This may include counselling, social development programs, or involvement in a restorative justice strategy. School disciplinary measures may also be taken to reinforce the seriousness with which the community takes all incidents of bullying. These measures may include internal school suspension, withdrawal from social events or celebrations or more severe punishments such as suspension or exclusion from school.

12.4 QASMT ANTI-BULLYING CONTRACT

The Anti-Bullying Contract provides a clear outline of the way our community works together to establish a safe, supportive and disciplined school environment. This contract is provided to all students and their parents/caregivers upon enrolment, and may be revisited with individual students if particular problems around bullying arise.+

13.0 APPROPRIATE USE OF SOCIAL MEDIA

The internet, mobile phones and social media provide wonderful opportunities for students to network and socialise online. While these technologies provide positive platforms for sharing ideas, they also have the potential to cause pain and suffering to individuals, groups or even whole communities.

It is important to remember that sometimes negative comments posted about the school community have a greater impact than expected. This guide offers some information about how to use social media in relation to comments or posts about the school community. Reputations of students, teachers, schools, principals and even parents/caregivers can be permanently damaged — and in some cases, serious instances of inappropriate online behaviour are dealt with by police and the court system.

Being aware of a few simple strategies can help keep the use of social media positive and constructive:

- Before you post something online, ask yourself if the community or individual really need to know. Is it relevant, positive and helpful?

- Remember that what you post online is a direct reflection of who you are. People will potentially form lasting opinions of you based on what you post online.
- Be a good role model. If things get heated online, consider logging out and taking a few moments to relax and think. Hasty, emotive responses could inflame situations unnecessarily.
- Be mindful when commenting, try to keep general and avoid posting anything that could identify individuals.
- A few years ago parents/caregivers may have discussed concerns or issues with their friends at the school gate. Today with the use of social media, online discussions between you and your close friends can very quickly be shared with a much wider audience, potentially far larger than intended.
- Taking a few moments to think about the content you are about to post could save upset, embarrassment, and possible legal action.
- As a parent/caregiver, you have a role in supervising and regulating your child's online activities at home and its impact on the reputation and privacy of others. Parents/Caregivers are their child's first teachers, so they will learn online behaviours from you.

13.1 IS IT APPROPRIATE TO COMMENT OR POST ABOUT SCHOOLS, STAFF OR STUDENTS?

Parental and community feedback is important for schools and the department. If you have a compliment, complaint or enquiry about an issue at school, the best approach is to speak directly to the school about the matter, rather than discussing it in a public forum.

While many schools use social media to update parents/caregivers of school notices, the department prefers that parents/caregivers contact schools directly with a compliment, complaint or enquiry due to privacy considerations. Imagine if your doctor, accountant or banking institution tried to contact you to discuss important matters via Facebook.

If you have raised an issue with a school, or know that another person has, consider refraining from discussing those details on social media, particularly the names of anyone involved.

Keep comments calm and polite, just as you would over the telephone or by email. If you encounter negative or derogatory content online, which involves the school, hinders a child's learning and/or affects the school community at large, contact the school principal.

13.2 POSSIBLE CIVIL OR CRIMINAL RAMIFICATIONS OF ONLINE COMMENTARY

A serious instance of inappropriate online behaviour may constitute a criminal offence and become a police matter. For example, online content may substantiate the offence of 'using a carriage service to menace, harass or cause offence' (Criminal Code Act 1995 (Cth) s. 474.17). School staff may contact their union or obtain personal legal advice if they feel that online content seriously impacts their reputation. Defamatory online content may give rise to litigation under the Defamation Act 2005 (Qld).

13.3 WHAT ABOUT OTHER PEOPLE'S PRIVACY?

If you upload photos of your student, be mindful of who might be in the background. You might be happy to share your child's successes with your friends and family via social media, but some parents/caregivers

are not. If you are tagging or naming students, consider that other parents/caregivers may not want their child's name attached to images online.

13.4 WHAT IF I ENCOUNTER PROBLEM CONTENT?

Taking the following steps may help resolve the issue in a constructive way:

- refrain from responding
- take a screen capture or print a copy of the concerning online content
- if you consider problem content to be explicit, pornographic or exploitative of minors, you should keep a record of the URL of the page containing that content but NOT print or share it. The URL can be provided to the school principal, or police, as needed for escalation of serious concerns
- block the offending user
- report the content to the social media provider.

14.0 RESTRICTIVE PRACTICES

School staff at QASMT need to respond to student behaviour that presents a risk of physical harm to the student themselves or others. It is anticipated that most instances of risky behaviour can be de-escalated and resolved quickly. On some rare occasions, a student's behaviour may continue to escalate and staff may need to engage immediately with positive and proactive strategies aimed at supporting the student to manage their emotional arousal and behaviour. Staff, students and parents/caregivers should read the QASMT Student Code of Conduct in conjunction with the QASMT Restrictive Practices Policy and the DOE Restrictive Practices Procedure.

In some very rare situations, where there is immediate risk of physical harm to the student or other people, and when all other alternative strategies have failed to reduce the risk, it may be necessary for staff to use restrictive practices.

The use of restrictive practices will always be as a last resort, when there is no other available option for reducing immediate risk to the student, staff or other people. Restrictive practices are not used for punishment or as a disciplinary measure.

The department's Restrictive practices procedure is written with consideration for the protection of everyone's human rights, health, safety and welfare. There are six fundamental principles:

1. Regard to the human rights of those students
2. Safeguards students, staff and others from harm
3. Ensures transparency and accountability
4. Places importance on communication and consultation with parents and carers
5. Maximises the opportunity for positive outcomes, and
6. Aims to reduce or eliminate the use of restrictive practices.

Very rarely restrictive practices will be planned and staff will employ, when necessary, pre-arranged strategies and methods (of physical restraint/ mechanical restraint/ clinical holding) which are based upon behaviour risk assessment or clinical health need and are recorded in advance. The use of planned

strategies will only be where there is foreseeable immediate risk consistent with the Restrictive practices procedure.

Seclusion will not be used as a planned response and will only be used in serious circumstances for managing an unforeseeable situation in an emergency. It will be used for the shortest time possible and in a safe area that presents no additional foreseeable risk to the student. In such emergencies, a staff member will observe the student at all times and seclusion will cease as soon as possible.

Following the use of any restrictive practice, a focused review will help staff to understand how they responded to the risk in any incident that involved the use of a restrictive practice. Staff will consider whether there are other options for managing a similar situation in the future. This strategy works well for reducing the use of restrictive practices.

All incidents of restrictive practices will be recorded and reported in line with departmental procedures.

14.1 IMMEDIATE STRATEGIES THAT STAFF MAY USE INCLUDE

- Avoiding escalating the problem behaviour
- Avoiding shouting, cornering the student, moving into the student's space, touching or grabbing the student, sudden responses, sarcasm, becoming defensive, communicating anger and frustration through body language
- Maintaining calmness, respect and detachment
- Modelling the behaviour that staff want students to adopt, stay calm and controlled, use a serious measured tone, choosing language carefully, avoid humiliating the student, be matter of fact and avoiding responding emotionally
- Approaching the student in a non-threatening manner; and
- Moving slowly and deliberately toward the problem situation, speaking privately to the student/s where possible, speaking calmly and respectfully, minimising body language, keep a reasonable distance, establishing eye level position, being brief, staying with the agenda, acknowledging cooperation, withdrawing if the situation escalates
- Where this impacts on the safety of self or others under potential threat, the teacher should call for assistance from a House Dean or members of the Leadership Team.

14.2 REINFORCEMENT AND CORRECTION STRATEGIES

- If a student starts displaying inappropriate behaviour, briefly acknowledge their choice and re-direct other students' attention towards their usual work/activity.
- If the student continues with the problem behaviour, then remind them of the expected school behaviour and identify consequences of continued unacceptable behaviour.

14.3 FOLLOW UP STRATEGIES

- Restore normal school operations as soon as possible; and
- Provide post-incident opportunities that include:
 - Assisting any distressed student/s to access appropriate support, e.g. Guidance Officer

- Assisting the individual student to identify the sequence of events that led to the unacceptable behaviour, pinpoint decision moments during the sequence of events, evaluate decisions made, and identify acceptable decision options for future situations
- Follow required processes for managing the behaviour incident and consequences.

14.4 PHYSICAL INTERVENTION

Staff may make legitimate use of physical intervention if all non-physical interventions have been exhausted and a student is:

- physically assaulting another student or staff member; or
- posing an immediate danger to him/herself or to others.

Appropriate physical intervention may be used to ensure that the Queensland Academy for Science, Mathematics and Technology's duty of care to protect students and staff from foreseeable risks of injury is met. The use of physical intervention is only considered appropriate where the immediate safety of others is threatened and the strategy is used to prevent injury.

Physical intervention can involve coming between students, blocking a student's path, leading a student by the hand/arm, shepherding a student by placing a hand in the centre of the upper back, removing potentially dangerous objects and - in extreme situations, using more forceful restraint.

It is important that all staff understand that:

- physical intervention cannot be used as a form of punishment; and
- physical intervention must not be used when a less severe response can effectively resolve the situation and the underlying function of the behaviour.

Any physical intervention made must:

- be reasonable in the particular circumstances
- be proportionate to the circumstances of the incident
- always be the minimum force needed to achieve the desired result; and
- take into account the age, stature, disability, understanding and gender of the student.

14.5 RECORD KEEPING

Each instance involving the use of physical intervention must be formally documented.

14.6 CRITICAL INCIDENTS

It is important that all staff have a consistent understanding of how to respond to emergency situations or critical incidents involving severe problem behaviour. This consistency ensures that appropriate actions are taken to ensure that both students and staff are kept safe.

An **emergency situation or critical incident** is defined as an occurrence that is sudden, urgent, and usually unexpected, or an occasion requiring immediate action.

Severe problem behaviour is defined as behaviour of such intensity, frequency, or duration that the physical safety of the student or others is likely to be placed in serious risk.
